#### Day 1 Sun. 23 July 2023 Stockholm

- Individual arrivals at the hotel
- Tonight, we gather to meet your Host and Tour Leader for a Welcome 3-course Dinner at a gourmet restaurant.
- Overnight in Standard Room at Clarion Sign (D)

#### Day 2 Mon. 24 July 2023 Stockholm, Vadstena area

- Meet your Tour Director after breakfast.
- Departure to Vadstena
- Entrance + Guided Tour + Visit of the Archives Vadstena Castle
  - Vadstena Castle was originally built in 1545 as a fortress to protect Stockholm from enemies from the south. The fortress was turned into a castle in 1620.
  - Since 1899, the castle has housed the Provincial Archives and today visitors can also find a Castle Museum with 16th and 17th century furniture, portraits, and paintings.
- Dinner and overnight in Standard Room at Vadstena Klosterhotel. (B, D)





#### Day 3 Tue. 25 July 2023 Östergötland/Göta Canal

- Breakfast at hotel and then meet your guide for another day of touring.
- Göta Canal Day cruise with lunch included on board.

oAboard the M/S Kung Sverker, you will experience a guided tour along the most beautiful part of the canal. During the trip, which takes 5 hours, we pass 12 locks and the steepest lock combination throughout the whole canal system. After the amazing five interconnected locks in Borenshult at a height difference of over 15 metres, we take a ride on Lake Boren to Borensberg, where we'll stop a while before turning back.

#### Day 4 Wed. 26 July 2023 Småland/Jönköping, Växjö Area

- Breakfast at hotel, then meet your Tour Leader and head for Växjö.
- Entrance Småland Museum, The Swedish Glass Museum, & The House of Emigrants, where you'll have opportunities for genealogy research.
- Founded in 1867, Småland Museum is Sweden's oldest county museum. Permanent exhibitions present objects from the 19th and 20th centuries. Småland Museum and the Swedish Glass Museum are two museums under the same roof. The Swedish Glass Museum is in the older parts of the museum and presents glass from all over the world and through all times.
- Dinner and lecture tonight.
- overnight in Standard Room at Elite Stadshotellet, Växjö (B, D)

## <u>Day 5 Thu. 27 July 2023</u> Småland/Växjö Area, day trip to Vilhelm Moberg sights/Kingdom of Crystal

- Following breakfast, meet your Tour Leader and Local Guide Ulf Nilsson for a full day program.
  - We will visit Ljuder church, Åkerby crossroads, Korpamoen croft, Kosta Glassworks, Granhult 800 year old church – the oldest wooden building in Sweden and Bergdala Glassworks (Hyttsill).
  - At Kosta Glassworks there will be time for lunch on your own (choose from two restaurants and a coffee shop) and for shopping (glass/crystal and other items) in the Outlet.
  - Guided tour in the Art Gallery and among some of the old houses in the village.
- Dinner is a Hyttsill in Bergdala Glassworks.
- Overnight in Standard Room at Elite Stadshotellet Växjö (B, D)



#### Day 6 Fri. 28 July 2023 Småland/Växjö Area, day trip to Kalmar & Öland

- Breakfast at hotel, then meet your Tour Leader for a full day excursion to Kalmar and Öland.
- Entrance Öland Museum with meal and lecture.
  - The Öland museum is situated in the local history centre of Himmelsberga. Himmelsberga is a village of carefully preserved buildings from the 18th and 19th centuries in which the visitor can experience a genuine historical environment, and enjoy exhibitions of contemporary and older works of art from the island.
- Overnight in Standard Room at Elite Stadshotellet Växjö (B,L)

#### Day 7 Sat. 29 July 2023 Östergötland/America Days

- Breakfast at hotel, followed by meeting your Tour Leader and Drive to Kisa / America Days festival. This day will be Peter Cassel Day (schedule to be announced).
- Overnight in Standard Room at Best Western Vimmerby Stadshotell (B)

#### Day 8 Sun. 30 July 2023 Östergötland

- Breakfast at hotel, followed by another day at America Days (Andrew Peterson Day).

#### Day 9 Mon. 31 July 2023 Östergötland, Stockholm

- Meet your Tour Leader and drive to Stockholm with stops on the way.
- Local guide for 3 hours for walking tour in Gamla Stan.
  - On this walking tour, you'll explore "Original Stockholm," more commonly known as the Old Town or *Gamla Stan*. You'll stroll through the narrow cobblestone streets and historic buildings dating back to the 16th century.
- Overnight in Standard Room at Clarion Hotel Sign. (B)

#### Day 10 Tue. 1 August 2023 Day trip to Uppland/Västmanland

- Breakfast at hotel.
- This morning meet your Tour Leader for full day of touring.
- Meet Local Guide for Uppsala and Västmanland
- Entrance Uppsala Cathedral
  - The cathedral was consecrated in 1435. All of Sweden's archbishops and the priests and deacons of Uppsala diocese are ordained here.
     Swedish kings and queens were crowned in Uppsala Cathedral until 1719. Several famous scientists are also buried here alongside royal personages and other greats.
  - This afternoon we stop in Biskopskulla, where the Bishop Hill Colony got its name.
- Dinner at Tortuna Bryggeri (grill and beer tasting), then bus back to Stockholm.
- Overnight in Standard Room at Clarion Hotel Sign (B, D)

### Day 11 Wed. 2 August 2023 Stockholm

- Breakfast at hotel, then meet your local guide for 4 hour touring
- Entrance Drottningholm Palace
- Drottningholm Palace is the best-preserved royal castle built in Sweden during the 1600s and it is representative of all European architecture that was to follow. In 1991 Drottningholm was included on UNESCO's World Heritage list of sites of outstanding universal value to humanity. The royal family moved into the Drottningholm Palace in 1981. Today the castle remains the primary residence of the King and Queen.
- Drottningholm boat on Lake Mälaren (one way)
- Afternoon at leisure.
- Tonight we gather for our farewell dinner.
- Overnight in Standard Room at Clarion Hotel Sign (B, D)

#### Day 12 Thu. 3 August 2023 Departure

Breakfast at hotel followed by individual departures. (B)
